Authorities and public participation of the Federal Maritime and Hydrographic Agency on the Site Development Plan and the environmental reports (North Sea and Baltic Sea) within the framework of the strategic environmental assessment

Dear Sir or Madam,

according to §§ 4ff. WindSeeG, the Federal Maritime and Hydrographic Agency (BSH) amends and updates the site development plan.

The site development plan with its designations serves to promote the development of offshore wind energy and grid connection subsea cables that are required for this. Its purpose is to achieve the legally set expansion targets for offshore wind energy, to expand electricity generation from offshore wind turbines in a spatially ordered and with an efficient use of space, to ensure the orderly and efficient use and utilisation of offshore grid connections and to plan, construct, commission and use offshore grid connections in parallel with the expansion of electricity generation from offshore wind turbines.

BSH addresses i. a. the following topics in the procedure of update and amendment of the site development plan:

- Spatial designation of additional areas and sites to achieve the statutory expansion target of at least 40 GW by 2035 and at least 70 GW by 2045.
- Spatial and temporal designation of offshore grid connection subsea cables and platforms
- Spatial designation of interconnectors
- Spatial designations and review of the definition for "interconnections"
- Adaptation of planning principles
- Adaptation of the spatial designations to the conditions resulting from the previous topics
- Determination of "acceleration areas" and grid infrastructure areas within the meaning of the Directive 2001/2018
- Determination of associated avoidance and mitigation measures.

A strategic environmental assessment is being carried out concomitantly.

The preliminary draft of the site development plan and the draft of the scope of the strategic environmental impact assessment were published on 1st September 2023. An online hearing on the (preliminary) draft documents and the comments of the transmission system operators took place on 2nd November 2024.

The North Sea and Baltic Sea riparian states were notified by letter dated 28th February 2024 in accordance with § 60 UVPG/ESPOO Convention.

The scope of the investigation for the preparation of the environmental reports of the strategic environmental impact assessment was established.

Based on the results of the consultation and the hearing, the draft site development plan and the environmental reports were prepared.

The national authority and public participation was initiated on 7th June 2024.
